### **INVITATION FOR BIDS**

**Coastal Energen Pvt Ltd (ENERGEN)**is setting up 2x600MW coal based Thermal Power Project in the Tuticorin District, in the state of Tamil Nadu in India. The Project is in an advanced stage of implementation.

Energen invites competitive offers from competent Vendors / Contractors for the construction of Main Gate way to the power Plant including execution of associated Civil works.

#### Brief scope of work

This is an iconic structure proposed to be provided at the entrance of the Main Plant to provide face lift to the entire Power Plant. Care shall be taken by the Successful bidder in achieving good workmanship and to provide elegance to the whole structure. The civil works required for Construction of Entrance gate way are included in the Scope. The scope also includes supply of all materials and labour along with necessary tools and tackles etc.as per the bid specifications.

#### 1.0 Minimum Pre-qualifying Requirements:

The Intending Bidders shall meet the following Pre-qualifying Requirements:

#### 1.1 **Technical Requirements:**

- (a) The Bidder should have constructed a building or a bridge of Rs. 100.0 lakhs contract value under one single agreement as a main contractor in the name or firm in which he or the firm intends to apply for this bid.
- (c) The work should have been completed during the last 5 (Five) years and in satisfactory service for one year as on the scheduled date of submission of completed bids.

## 1.2 Financial Requirements:

The Bidder shall be financially sound and shall have adequate financial resources to execute the contract concurrently with his other commitments and shall meet the following conditions:

a) The Bidder shall have a positive net worth as per latest audited financial statements.





- b) The Bidder shall have an average annual turnover of not < Rs. 5.0 (Five) crores during the last 3 (Three) years ending on 31-03-2011.
- c) The Bidder shall furnish his audited profit & loss account and balance sheet for the last 3 years ending on 31.03.2011.
- d) Contracts on hand /pending jobs and their status along with value also should be furnished by the bidders.
- 2.0 Documentary evidence required in support of qualifying Requirements. Bidder shall furnish documentary evidence to satisfy the qualifying requirements as in Clause 1.1&1.2 above.

#### Issue of Bid documents:

Interested Bidders or their authorized representatives who meet the above qualifying requirements may collect the Biddocuments from the following address in person/ by post/ by courier on submission of a written request along with supporting documents to demonstrate meeting the above qualifying requirements.

## **Earnest Money Deposit**

The bidder shall submit a Demand draft or a Bank Guarantee from a nationalised/scheduled bank for an amount of Rs1.00 (one) lakh towards EMD. The Bank Guarantee shall be valid for a period of Four months from Bid date. The Earnest Money Deposit paid in the form of Demand Draft will be refunded by means of Accounts Payee Cheque to the unsuccessful Bidder as soon as the award of work is finalised. This amount shall not carry any interest. In case of successful Bidder, the EMD shall be returned after the Security Deposit/Contract Performance Guarantee is furnished on award of contract. The EMD will be forfeited if the Bidder (i) withdraws his Bid after acceptance or (ii) withdraws his Bidder before the validity date.
